- Standard Teaching License must complete required number of Biblical Studies CEUs annually
- Non-tax Teaching License must maintain current ACSI certification
- Ability to take initiative, work independently, and hold oneself accountable
- Ability to manage multiple responsibilities with converging deadlines while maintaining a positive, can-do attitude
- Ability to develop original ideas
- Capable of finding solutions to challenges and obstacles
- Willingness to adjust priorities as needed
- Ability to work effectively with others
- Initiative to learn new skills, techniques, and ways to accomplish projects and goals
