OTHER ENROLLMENT FEES:

- 1. Application Fee: \$50. This is a one-time, non-refundable, new student fee due when the application is submitted. The fee is valid for one application year.
- 2. Enrollment Fee: \$375. This is a one-time, non-refundable, new student fee due when the enrollment packet is submitted.
- 3. Continuous Enrollment (CE) Fee: \$375. This is a per student fee that is billed each year after the start of 2nd semester to hold the student's place for the following school year. The fee is non-refundable and recurs annually until one of the following occurs: graduation, withdrawal, or dismissal.
- 4. Student Services Fee: \$800. This is a per family fee that is billed annually with tuition and follows the annual or monthly payment plan. Previously known as the "Facility Fee," this supports non-tuition items such as technology, facilities, and security.

TUITION PAYMENTS: WC uses FACTS Management Co. to process all tuition payments, so every family is required to set up an online FACTS account. We offer two payment options:

- Monthly The annual tuition is paid in 12 monthly installments from July-June. Families choosing this plan will need to provide FACTS with a financial account from which the funds will be drafted on either the 1st or the 15th of the month. This may be either a bank account or a credit card. For credit card payments, a small merchant fee is added to each monthly payment. FACTS will charge a fee for attempted payments that fail due to non-sufficient funds. FACTS charges a \$55 annual set-up fee for families who choose to use a monthly payment plan.
- **Annual** The annual tuition is paid in a lump sum by July 31st. Families who choose an annual payment plan will not incur a FACTS fee <u>and</u> will receive a 1.5% prepay discount off their net tuition (after all scholarships and discounts).

DISCOUNTS: A Ministry Support discount is extended to members/attenders of Grace Polaris Church who support the church with regular giving.

SCHOLARSHIPS: WC participates in three different scholarship programs: Ohio EdChoice, Ohio Christian Education Network Scholarship Granting Organization, and our own in-house program. Scholarship applications may be requested after a WC new student enrollment packet has been completed.

FINANCIAL AGREEMENT: All tuition charges, fees, and fines must be paid in a timely manner. **All accounts must be current at the end of the quarter, or your child(ren) will not be able to start the new quarter.** If your account is not fully paid on or before June 30, your student may be placed on a waitlist for the following year. Diplomas will be held for seniors who are not paid in full. Transcripts and cumulative records will not be released, and student schedules and classes will not be finalized until all finances are up to date.

STUDENT WITHDRAWAL: Please contact Erin Smith (614-410-4234) in the finance department or Susan Sewall (614-410-4300), enrollment coordinator. There are no penalties for withdrawals before 2/28/2026.

- Withdrawal BEFORE the school year begins:
 - Withdraw from 3/1 5/31 10% of tuition and fees for coming year due
 - Withdraw from 6/1 7/31 15% of tuition and fees for coming year due
 - Withdraw from 8/1 first day of school 20% of tuition and fees for coming year due
- Withdrawal DURING the school year:
 - Withdraw during 1st guarter 25% of annual tuition and fees due
 - Withdraw during 2nd quarter 50% of annual tuition and fees due
 - Withdraw during 3rd quarter 75% of annual tuition and fees due
 - Withdraw during 4th quarter 100% of annual tuition and fees due
